2. The Visiting Team is to mail the scoresheet to the Division Director with-in 12 hours of the completion of the match.  
If not, a 3 point penalty will be assessed.

3. In the event a match is postponed, the Home Team will call the Recorder and inform him that the match was postponed.  
The Visiting Team will mail the scoresheet marked "POSTPONED" to the Division Director. A 1 point penalty will be assessed for failure to comply. NEW RULE-see letter in folder for specifics.

4. Any postponed matches must be replayed within 14 days weeks of date. Both teams will receive 0 points if this rule is not followed.  
NO POSTPONEMENTS IN LAST TWO WEEKS OF SEASON.

5. The score sheets must be signed by both Captains. Their full signature is required. If not, players will not receive credit for their 171+, high-ons and high-offs. PLEASE CIRCLE ALL OUTS for BOTH TEAMS
